EDUCATIONAL PROGRAMS IN CHINA

- **Leading AI Patent Growth:** China currently holds six times more patents in generative AI than the United States.
- **Robust R&D Investment:** China's research and development spending has witnessed a substantial increase, reaching \$458.95 billion, representing an 8.1% growth.
- **Global Leader in R&D Investment:** China has surpassed the European Union in R&D investment, solidifying its position as a global leader in this area

According to the "China AI Development Report 2018", China's share of global AI research output rose from 4.26% in 1997 to 27.68% in 2017, exceeding the United States and other leading nations, highlighting the country's ambitions in science and technology. This trend continues to this day.

BUSINESS MISSIONS

India

India's economy continues to be the fifth largest in the world, with a GDP of \$3.82 trillion in 2023. India surpassed both the United Kingdom and France in GDP size in 2019. With \$8.9 trillion in purchasing power parity (PPP) GDP, India is ranked third in the world.

Indonesia

Indonesia, Southeast Asia's largest country and a resource-rich nation with a population of over 270 million, shows sustainable economic growth. The Indonesian government and local authorities promote a business-friendly environment for foreign companies. It offers several prospects and provides numerous opportunities in the Indonesian market.

UAE

The UAE offers a zero-tax rate for most income. The only significant tax is a 5% value-added tax, which applies to companies with annual revenue exceeding 375,000 dirhams.
